1. What is a National Framework Agreement?


The framework agreement places no obligations on the Members to use these suppliers should there be no demonstrable benefits. There is also no guarantee that upon conclusion of the tender process, contracts and/or orders will arise for the prequalified suppliers on the framework agreement panel.

2. Contract background

2.1. Contract Value/Spend

PURCO SA Membership has procured to the value of approximately *R40 Million on this contract for the past three (3) Years using a panel of contracted suppliers. This collaborative spend although not guaranteed, is a potential estimated value for the next three year contract period.

Trained driver/supervisor and loading crew.

Protective clothing for move personnel.

Supervisor must be able to write up a detailed inventory and label all items.

Suitable weatherproof warehouse with adequate valid fire protection equipment.
