



REQUEST FOR PROPOSAL (RFP)

WITS SERVICES DEPARTMENT TENDER 2023:25

Provision of General Waste Management Services

The **Services Department** of the University of the Witwatersrand, Johannesburg, in collaboration with Purchasing Consortium of Southern Africa (PURCO SA), invites tenders for General Waste Management Services that meet the requirements of the University as specified in the tender pack. The scope of work comprises of three distinct components:

The University strictly prohibits any joint ventures or partnerships for all components. Subcontracting is allowed for Component 1 and 2 only, provided that the subcontractor complies to legislative requirements and applicable licensing.

Component 1 - General Waste Management Services - Handling, Collection, Removal, Classification, Diversion, Treatment, Recovery, Transportation, and Disposal.

The services required includes handling, collecting, removing, classifying, diverting, treating, recovering, transporting, and disposing of from the University precincts to landfill sites recycling centres, and treatment areas.

Component 2 - General Waste Management Services – Leasing Machinery and Equipment and Vehicles

The services required includes the leasing of general waste management vehicles, equipment, and machinery.

Component 3 - General Waste Management Services – Supply of Consumables and Waste Bins

The services required includes the supply of waste management consumables and bins.

The eligibility criteria is stated in the tender documents. Tenderer's who meet the criteria are eligible to have their submissions evaluated.

Submission Details: The closing date and time for receipt of the tender submission is on **Friday, 29 September 2023 at 23h59 (before mid-night)**. E-mailed, Telegraphic, telephonic, telex, facsimile, physical and late submissions **WILL NOT** be accepted.
