



SPECIFICATIONS FOR THE SUPPLY AND DELIVERY OF STEEL CONSUMABLES FOR THE PERIOD OF 36 MONTHS

SCOPE OF WORK

1. TENDER REQUEST

Provision for the panel of service provider (s) to supply various consumables to Northlink TVET College on a when-required basis for 36 months.

2. BACKGROUND INFORMATION

Northlink College is a Public Technical and Vocational Education and Training College and a key component of government as it conducts and coordinates Education and Training on behalf of the Department of Higher Education and Training. Northlink College has seven (7) campuses which are geographically located across the Northern areas of the Cape Town Metropole, Western Cape. The Central Office is located at 80 Voortrekker Road, Bellville.

The panel of service provider (s), main focus is on the provision of various consumables to the college campuses. The objective of this tender is to have a multidisciplinary reliable panel of supplier/service provider (s) in place that will supply and deliver various consumables.

Northlink College, through its employees, conducts business on a daily basis with its customers (students), suppliers, and communities as well as with the state and other authorities. During these interactions, the campuses require these consumables to be able to fulfill their functions on-site.

The consumables will be grouped as per commodities. The interested suppliers /service provider(s) are required to provide the price on all listed items The suppliers /service provider(s) to provide the alternative product should the listed items be discontinued. The panel of suppliers/ service provider(s) can be awarded per commodity. Where the item has various sizes, ensure you provide the pricing of the biggest size.

- 4. Delivery
 - **4.1** The goods must be delivered to all Northlink College sites, the physical address will be shared with the appointed suppliers/service provider (s).
 - **4.2** The appointed service provider must be able to deliver the goods within six (6) weeks from the date of the official order issued by the college.
 - **4.3** No part deliveries will be accepted, all items must be delivered at once per the official purchase order
 - **4.4** The appointed service provider(s) must be able to deliver the items in urgent cases.

5. Pricing

- 5.1 Delivery fee must be included in the pricing
- **5.2** The pricing must remain fixed for the duration of the contract. The increase will only be accepted if there is a reasonable change in the economy or at the affected industry.
- **5.3** The letter of increase will only be approved by the Deputy Director of Financial Services or a delegated person.
- **5.4** The college reserves the right to negotiate the prices if the items are not market-related.

6. Quality and Quantity

- **6.1** The college is expecting to receive good quality consumables as these items are utilized for teaching and learning.
- **6.2** Any received inferior consumables will be returned to the supplier or service provider.
- 6.3 Guarantee periods and what does not constitute must be indicated.
- **6.4** Where required, all consumables offered in this tender shall comply with the latest relevant codes of the South African Bureau of Standards (SABS).

7. Samples

7.1 The college may request samples of items before purchasing.

8. Payments

30-day payment will be processed after receiving a valid tax invoice(s) and statement. No payment will be made in partial deliveries.
