SPECIFICATION:

Sanitary bins necessary for the disposal of feminine hygiene products such as tampons and pads. These items brimming with bacteria and germs, which can cause illness and contamination if not consistently discarded.

PURPOSE:

Request for the appointment of a service provider for servicing and maintenance of SHE bins for a period of 24 Months for Eastcape Midlands TVET College campuses.

LOCATION:

The product services shall be provided at various buildings within Eastcape Midlands TVET College including Uitenhage, Port Elizabeth, Grahamstown and Graaff Reinet Campuses.

COORDINATION:

The service provider and their personnel shall coordinate all activities in consultation with the Camus Managers and their cleaning supervisors as and when required.

SCOPE OF WORK AND FREQUENCY:

The service provider is expected to perform the following duties namely:

- Servicing a total of 154 existing SHE bins and removal and disposal of contents on weekly basis at various ladies bathrooms within the campuses.
- All liner bags must be changed weekly at each campus.
- The successful service provider should provide a service schedule.
- The Service provider will be requested to submit proof of safe disposal certificates

GENERAL SAFETY, HEALTH AND ENVIRONMENTAL (SHE) REQUIREMENTS:

The service provider shall:

- Create and maintain a safe and healthy working environment for its own staff and those
 of ECM.
- Execute the work in a manner that complies with all the requirements of OHSA.
- Provide all related working equipment such as protective clothing, etc. to ensure the safety and health of its own staff and those of others.

THE PALN SHOULD EMPHASIZE THE FOLLOWING:

- The process and responsibilities for the removal and disposal of sanitary waste in compliance with the legislation, National Environmental Management: Waste Act (Act 59 of 2008).
- The legal disposal of SHE sanitary waste collected.

TARGET COMPLETION DATE:

The services are expected to commence as soon as possible as and when required for a period of 24 months.
