## **SPECIFICATION**

### **PURPOSE OF THE TENDER**

The purpose of this request is to solicit proposals bidder(s) for the cleaning of the 40 Centres in compliance with COVID 19 regulations of The KwaZulu-Natal Community Education & Training College.

This request for proposal (RFP) document details and incorporates, as far as possible, the tasks and responsibilities of the cleaning of the identified Centres in compliance with COVID 19 regulations of The KWAZULU –NATAL Community Education & Training College. This RFP does not constitute an offer to do business with the KWAZULU –NATAL Community Education & Training College but merely serves as an invitation to bidder(s) to facilitate a requirements-based decision process.

### **SCOPE AND DEFINITION OF WORK**

#### **BACKGROUND**

The College's primary objective in issuing this RFP is to enter into a 36-month agreement with a suitable service provider to provide cleaning services at all Identified Centres of the KWAZULU-NATAL Community Education and Training College.

#### **SERVICE REQUIREMENTS**

##### **Duties/ Description for personnel but not limited to:**

- Cleaning Services in Classroom (Sweeping, Moping, Dusting, window frames, and interior wall cleaning & other surfaces)
- Clean reception areas • Dustbins to be emptied every morning
- Replacement of consumables i.e. toilet paper and hand soap
- Clean all toilets bowls, seats, hand bins, urinals and mirrors
- Pick up litter and remove to specific area
- Sweep entire parking area, pave for litter free
- Removal of all refuse, paper, tins and domestic waste
- Vacuum floors and carpets
- Sweep floors with implements that control dust
- Mop flows with detergent to remove dirt's and bacteria
- Strip the floor with a non-ammoniac stripper

- Tables dusting and dam wipe chairs
- Vacuum chairs that are water resistance
- Dusting of cabinets, pedestals, filling cabinets, furniture and desk
- Toilets to be rechecked and maintained
- Clean door handles deep cleaning
- Wash equipment's
- Store all equipment, materials in the storerooms
- Lock storeroom
- Yard Maintenance (1. Cutting of grass 2. Cutting Trees)
- Cleaning toilets and replacing toilet essentials.
